Nominations

There are four (4) NIFEDCU Board of Director positions up for election. The election will not be conducted by ballot and there will be no nominations from the floor when there is only one (1) nominee for each position to be filled. Board of Directors serve three (3) year terms.

The Nominating Committee, appointed by the Chairman of the Board of Directors, has nominated three (3) incumbent Board Members including Judy Peterson, Donald Bull and Jim Stemmler along with one (1) new nominee, Mary Ann Hunt.

Nominations may also be made by petition. Nominations by petition must be accompanied by a petition signed by 1% of NIFEDCU members and include a statement of qualification and biographical data. Nominations must also be accompanied by a signed certificate from the nominee stating they are agreeable to the nomination and will serve if elected to office. Nominations by petition must be received by 5 p.m., April 1, 2024.
